Confirmed the site is down. But it looks like a TLS certificate issue that could be part of normal site maintenance. It still shows up as the number-one Google result for me for the query "RAFA Academy Utah." An archived version of the site is available here https://web.archive.org/web/20240301024811/https://rafaacademy.org/.

The site made no reference to RAFA as an acronym or abbreviation. Neither I nor the general public know if it is either.

The L.L.C. is registered as "Rafa Academy." See attached.

In any event, is this L.L.C. licensed by your department? Or is any organization actively licensed at either 1) 433 Diamond Ranch Parkway, Hurricane, Utah 84737, or 2) 505 Hope Circle, Hurricane, Utah 84737?
